
**Quorum** : - The quorum for the Board of Studies meeting shall be 50% of the members which shall include at least one outside expert.

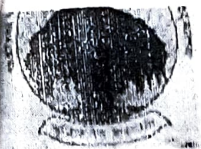

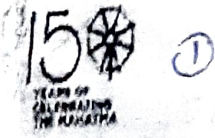


