2. The Estimated cost of work is Rs99515/- (Rupees Ninety nine thousand five hundred and fifteen only)
3. Last date of submission of Quotation is 10.03.2023 at 12:00 hrs
4. Date of Opening of Quotation is 10.03.2023 at 15:00 hr or as decided by the convenor LPC.
5. Validity of Quotation is 45 days from the date of opening of Quotation.
6. Bidders quoting percentage item wise shall be summarily rejected. Rates are inclusive of all taxes, hiring of machinery like hydra for shifting, loading Unloading, transportation Octroi, cess, GST etc. Rates are FOR at site.
7. Statutory deductions like TDS & Labour cess as per applicable rates will be made from the contractor's bill.
8. Rates quoted shall be firm and fix and no escalation shall be provided throughout the currency of the period of work.
9. The Quantities shown are tentative and the quantity may increase or decrease with in permissible limits at the time of actual execution of work.
10. Payment shall be made as per the actual work done based on actual measurement at site.
11. All the materials used in the work shall be ISI marked.
12. No advance payment will be made.




