BRS-1 / Item No. 02

To consider creation of Research facilities in the University

Resolved that common Research Lab be created. Further, a Master Instrument Index be prepared in which the details of all equipments / instruments / resources available in the university shall be recorded for common use by the faculty and scholars to avoid multiple procurement of such equipments / instruments.

It was also resolved that a Server for Databases / Resources shall be purchased for the University. For this purpose, following two member committee was constituted:

To examine and review the status and progress of Research in each Department of the University

Resolved that every Research scholar will submit Bi-annual Progress Report to Dean, Research Studies till the completion of Ph.D. Further, every Research Scholar will present Open House Presentation before Departmental Research Committee every six months.

University scholarship of only those Scholars will be released who achieve minimum 20% Progress in Ph.D. every year.

BRS-1 / Item No. 05

To consider norms for consultancy services and sharing of Revenue between Project Investigator and the University


Resolved that 70:30 ratio be followed in case of consultancy services. For projects 20% of total funds will be deposited in Central University of Jammu funds as overhead cost / expenditure.

Also resolved that each faculty has to publish at least 02 Research Papers / evidence of submission every year failing which the matter may be reported to the Executive Council of the University.


Other suggestions

- Prof. Alka Sharma suggested that some seed money should also be provided to the students of the Master Degree program to pursue research/start-ups in their specialised areas. The Vice Chancellor informed that the university is already providing Rs. 2 lakh funding to the faculty for doing research projects.
- The Vice Chancellor suggested that Scholars be admitted to Ph.D. programs in the Departments / Centres subject to availability of eligible faculty and infrastructural facilities.
