\*The Chairperson will take prior approval of the competent authority.

कार्यकाल: - ए और बी के अलावा अन्य सदस्यों के कार्यालय की अवधि तीन वर्ष होगी।

**Tenure** : - The term of office of members other than a and b shall be three years.

गणपूर्ति: - अध्ययन बोर्ड की बैठक के लिए गणपूर्ति 50% सदस्यों की होगी जिसमें कम से कम एक बाहरी विशेषज्ञ शामिल होगा।

**Quorum** : - The quorum for the Board of Studies meeting shall be 50% of the members which shall include at least one outside expert.

2. शोधार्थियों से संबंधित सभी मामलों में संबंधित पर्यवेक्षक को आमंत्रित किया जायेगा।

In all matters pertaining to research scholars, the concerned supervisor shall be invited.

3. बोर्ड ऑफ स्टडीज सामान्यतया वर्ष में कम से कम दो बार और ऐसे अवसरों पर मिलेंगे जो माननीय कुलपति द्वारा निर्धारित किए जा सकते हैं।  
The Board of Studies shall ordinarily meet at least twice a year and on such occasions as may be determined by the Hon'ble Vice-Chancellor.
